BOAT COMMITTEE

Report by Monica Futty:

This is our year to maintain the buoys. It will be done in a week or so that is why there are no boats out yet.

For some History:

The Boaters committee wrote a memo of understanding which you can find on the community website

They will maintain and review the buoys every 2 years by a professional so they will be safe.

The buoys moved northward during the storm a couple of years back. The neighbors to the north, the Fetterman's, have boat access issues due to this. To address this, the buoys will be moved back towards the center and their arrangement flipped.

The professional diver, Zach, will be coming to maintain and reposition them.

This is paid for by the boat owners. In addition, they each pay an annual fee to the RPCC Restricted Dock Maintenance and Repair Fund. This "Dock Fund" currently has a balance of \$700.00.
